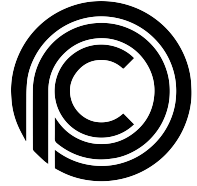

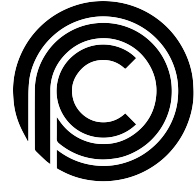

The Organization declares that it has no conflict of interest with the affiliated hotels and that the sole purpose of its involvement is to assist Players seeking accommodation.

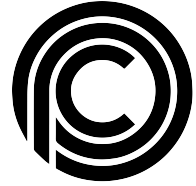

Liability Waiver and Assumption of Risk Declaration

The **Player** declares that all activities carried out with the **Organization** during the period from June 1 to August 31, 2026 are undertaken on a voluntary basis. The Player declares to be fully aware that, by participating in the activities, he or she fully accepts, without any exception, all the General Conditions set forth below.

1. *The Player declares to be in possession of a valid medical certificate for competitive sports activity, which is attached hereto, and releases the Organization from any civil and criminal liability, whether direct or indirect, related to and arising from the verification of such fitness.*
2. *The Player undertakes, under penalty of exclusion from the activities, to maintain conduct consistent with the principles of fairness, sportsmanship and compliance with the rules, refraining in any case from conduct contrary to the law or likely to endanger his or her own safety or that of others.*
3. *The Player releases the Organization from any direct or indirect liability for any material or non material damages, as well as for any expenses of any kind, arising from participation in the activities, even where such damages result from the Player's own conduct, except as otherwise provided in cases of willful misconduct or gross negligence of the Organization.*
4. *The Player declares to knowingly accept all risks connected with and inherent in the activities carried out and releases, to the extent permitted by law, the Organization and any person or party involved from any civil and criminal liability.*
5. *The Player declares to have been informed by the Organization and to be fully aware that, during the activities, the presence of a doctor or an ambulance is not guaranteed. By signing this document, the Player expressly waives any civil, criminal or recourse action against the Organization for direct or indirect damages that may occur as a consequence of the absence on site of a doctor or an ambulance, to the extent permitted by law.*
6. *By signing this document, the Player assumes full responsibility arising from the performance of sports activities and releases the Organization and any person involved from any civil and criminal liability, including strict liability, in relation to injuries caused to himself or herself or to third parties, as well as illnesses occurring during the entire duration of the activities or resulting from the use of facilities and the playing field. The Player further releases the Organization from any liability related to theft, loss or damage to personal belongings.*
7. *The Player declares to be solely and exclusively responsible for his or her stay in hotel, hostel, apartment, campsite or bed and breakfast accommodation, even if the Organization provides assistance in the booking process.*
8. *The Player declares to be fully responsible for all movements and transfers carried out during the days of activity and fully releases the Organization from any liability in this regard.*
9. *The Player authorizes the Organization and all parties involved to take photographs and video recordings during the sports activities and to use, store and distribute such images and audiovisual materials for informational, promotional and documentary purposes related to the Organization's activities, including publication on printed materials and digital platforms, including websites and online channels. Photographic and video materials shall be made available to the Player, who shall have free access and use thereof, and to participants who have validly signed the present authorization. Should the Player not wish to grant this authorization, he or she must notify the Organization in writing at the time of registration.*

Specific Approval Clause

Pursuant to Articles 1341 and 1342 of the Italian Civil Code, the undersigned Player declares to have carefully examined all 9 clauses of the General Conditions contained in this liability waiver and specifically approves clauses nos. 3, 4, 5, 6, 8 and 9, as well as to have read and fully accepted the remaining clauses. This liability waiver must be read, approved and signed by the participant in the activities and, if the participant is under eighteen years of age, by a parent or legal guardian.

Authorization for the Processing of Personal Data

Should the Player be under eighteen years of age, the undersigned parent or legal guardian declares to have read, understood and approved this authorization, signing also in the name and on behalf of the minor.
